### **2.How do we collect personal information?**

We generally collect information about you from Fact Find, emails, phone calls, face-to-face meeting and online client portals (Adviser Logic, MyProsperity and/or Praemium). We may also obtain credit information about you from credit providers and credit reporting bodies on your behalf if necessary for us to provide our services to you.

### **3.Why do we collect personal information?**

Lantana Private Wealth collects and holds personal information for the purposes set out in the Lantana Private Wealth Privacy Policy.

### **4.Consequences of not providing us with the information**

If you do not provide some or all of the personal information requested by us, we may be unable to provide you with our products or services.

### **5.Use and disclosure of information**

We may use and disclose the personal information we collect about you for the following purposes:

- to assist Lantana Private Wealth in providing a product or service to you;
- completion of documentation and application forms;
- to consider and assess your request for a product or service;
- to provide you with information about a product or service and invite you to marketing events;
- to protect our business and other clients from fraudulent or unlawful activity;

- to consider any concerns or complaints you may have;
- to conduct our business and perform other management and administration tasks;
- to manage any legal actions involving Lantana Private Wealth;
- to comply with relevant laws, regulations and other legal obligations; and
- to help us improve the products and services offered to our clients, and to enhance our overall business.

### **6.Who will the information be disclosed to?**

The types of organisations to whom we may need to disclose your personal information to include:

- financial product issuers and credit providers;
- a debt collector; and
- anyone else to whom you authorise us to disclose it.
